BFHD's Food Safety Team inspects over 1,000 retail food establishments that serve food to the public. The following comments are taken directly from the latest inspections conducted at these facilities. Red violations are those most likely to cause food-borne illness, such as improper temperature control of food or poor personal hygiene (i.e., lack of hand washing, bare-hand contact with foods). Blue violations are low risk factors relating to the cleanliness and physical condition of a food establishment, such as poor dishwashing practices or unclean facilities.

Routine inspections with 35 or more red points will incur a follow-up inspection. A follow-up with 25 or more red points or 10 repeat red points will incur an additional follow-up. All inspections take place without notice and ideally during the establishment's regular business hours. An inspection with 0 red points and 0 blue points indicates no violations were cited at the time of the inspection.

All kitchen and wait staff are required to have a WA State Food Worker Card (FWC).
