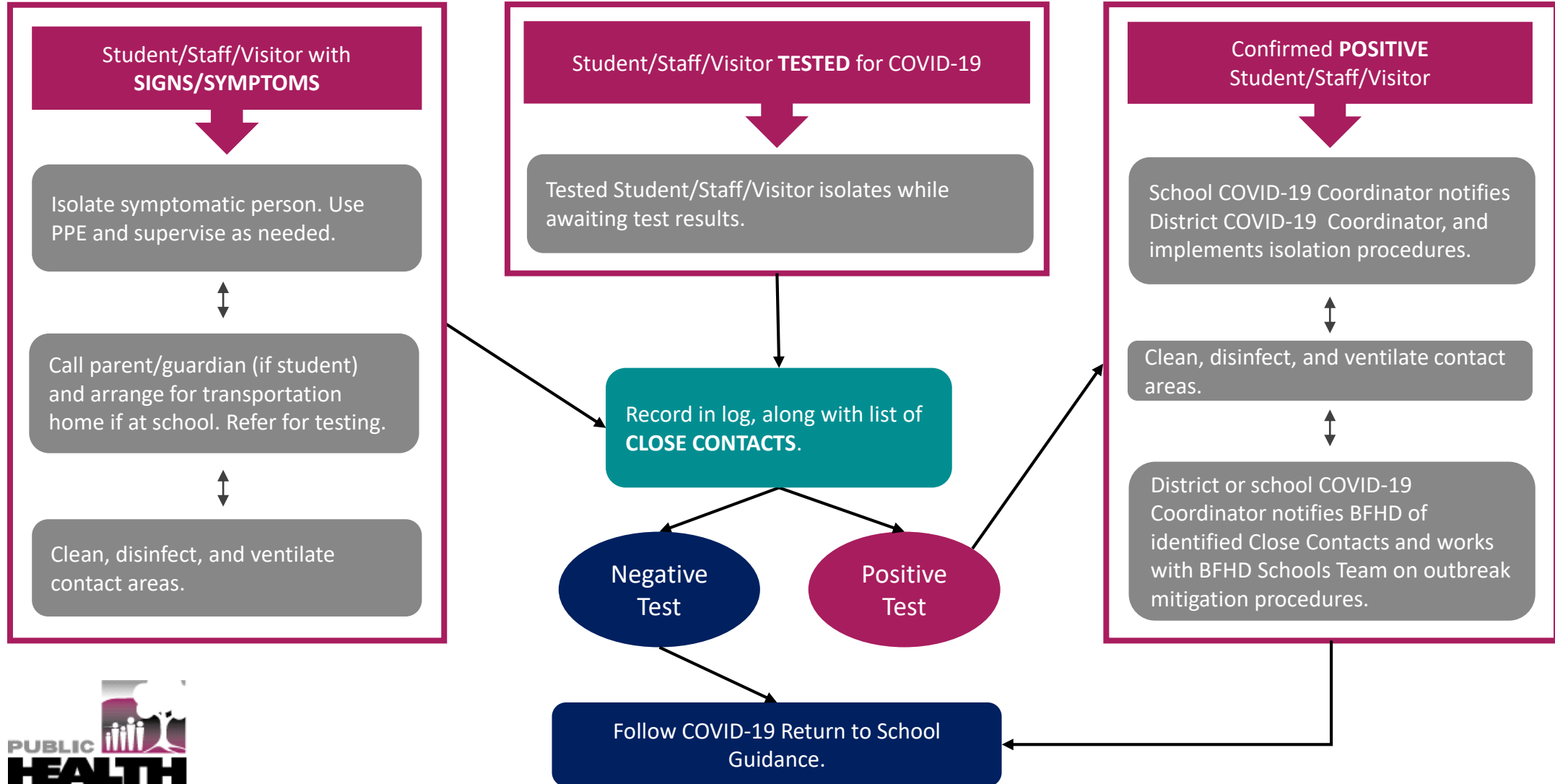


COVID-19 Reporting Guidance for Schools

For all situations, the Building COVID-19 Coordinator will notify School District COVID-19 Coordinator and communicate with BFHD Schools Team per District Policy.



COVID-19 Return to School Guidance

Situation	Can return to school
<input type="checkbox"/> Close Contact with Positive Case or Probable Case *Return to school guidance applies, regardless of negative test result	<p>Symptomatic</p> <ul style="list-style-type: none"> • 10 days after symptoms started and • At least 24 hrs fever free (without use of fever-reducing medication) and • Other symptoms have improved <p>No Symptoms</p> <ul style="list-style-type: none"> • 14 days after last contact with positive case (can be waived for essential employees who remain symptom-free and can adhere to safety precautions)
<input type="checkbox"/> Positive COVID-19 Test	<p>Symptomatic</p> <ul style="list-style-type: none"> • 10 days after symptoms started and • At least 24 hrs fever free (without use of fever-reducing medication) and • Other symptoms have improved <p>No symptoms</p> <ul style="list-style-type: none"> • 10 days after test collection date
<input type="checkbox"/> Any <u>Class A Symptoms</u> or <input type="checkbox"/> 2 or more <u>Class B Symptoms</u> of any duration or <input type="checkbox"/> 1 or more <u>Class B Symptoms</u> lasting more than 24 hrs and No Known Exposure or Close Contact	<p>With negative PCR COVID-19 Test Result and/or alternative diagnosis from HCP that explains all symptoms</p> <ul style="list-style-type: none"> • 24 hrs fever free (without use of fever-reducing medication) and • Other symptoms have improved or • Per condition diagnosed by HCP (whichever is longer) <p>Without COVID-19 Test or HCP diagnosis</p> <ul style="list-style-type: none"> • 10 days after symptoms started and • 24 hrs fever free (without use of fever-reducing medication) and • Other symptoms have improved
<input type="checkbox"/> 1 <u>Class B Symptom</u> that resolves within 24 hrs and No Known Exposure or Close Contact	<ul style="list-style-type: none"> • 24 hrs fever free (without use of fever-reducing medication) and • Other symptoms have improved

Symptoms Consistent with COVID-19 (not related to a pre-existing condition)
<p>Class A Symptoms</p> <ul style="list-style-type: none"> • Fever (100.4 or over) • Cough • Loss of taste or smell • Shortness of breath or difficulty breathing <p>Class B Symptoms</p> <ul style="list-style-type: none"> • Fatigue • Headache • Muscle or body aches • Sore throat • Congestion or runny nose • Nausea or vomiting • Diarrhea (2 or more loose stools in 24 hrs)

Close Contact: Individuals within 6 ft for 15 or more minutes to a confirmed case during the infectious period

Probable Case: Symptoms and Close Contact with Positive Case

Infectious Period: Begins 48 hrs prior to symptom onset

Alternative Diagnosis: Lab-confirmed diagnosis such as strep throat or viral pathogen. Can also include childhood rash illness, acute otitis media, etc. (COVID-19 test still strongly recommended in addition)

*Secondary Close Contacts do not need to quarantine unless the Primary Close Contact tests positive or develops symptoms
